### EARLY YEARS GOVERNMENT FUNDED CHILDCARE

The school also offers **up to 15 hours of childcare funding** for 3 to 5 year olds (up to and including the term of their fifth birthday). This will be shown automatically on your termly invoice. You do not need to apply for this separately. The school also offers **up to 30 hours of childcare funding** for 3 to 5 year olds if you meet the eligibility criteria - [Apply for free childcare if you're working - GOV.UK](#)

From April 2024, eligible working parents of 2-year-olds will be able to access **15 hours per week of childcare funding**, which is then deducted from each term's fees when the child is 2 years old. From September 2025, eligible working parents of children aged 2 will also be able to apply for **30 hours free government funded childcare**. You will need to meet the [eligibility criteria](#) before you can claim 15/30 hours free childcare. You can apply online here on [Gov.uk](#).

## CHILDCARE VOUCHERS

The School accepts the following for fees up to and including the term in which your child turns 5. After this time, these payment methods will only be accepted for before and after school care and after school activities.
